प्रस्तावना-

स्नातक स्तर पर अनुवाद का प्रमाण पत्र पाठ्यक्रम भारतीय भाषाओं तथा अंग्रेजी-हिन्दी से अनुवाद की तकनीकी कौशल निर्माण के उद्देश्य को केंद्रित करके तैयार किया गया है। भारत जैसे विशाल बहुभाषिक, राष्ट्र के लिए अनुवाद एक महत्वपूर्ण सेतु का कार्य करता है। देश की भाषिक, सांस्कृतिक, साहित्यिक इत्यादि विविधता में एकरूपता के लिए अनुवाद की अनिवार्यता है। इस दृष्टि को केंद्रित रखते हुए साहित्यिक, व्यावसायिक, वाणिज्यिक, शासन, प्रशासन के अनुवादों की आवश्यकता निरंतर बनी हुई है। इस कमी को पूर्ण कराने के लिए अनुवाद की अनिवार्यता स्वतः सिद्ध हो जाती है। वर्तमान समय में विभिन्न अंतरानुशासनिक ज्ञान का समेकित रूप में आदान-प्रदान कराने हेतु तथा विविध रोजगार की संभावनाओं को दृष्टि में रखते हुए यह पाठ्यक्रम विद्यार्थियों के लिए लाभदायक सिद्ध होगा।
